## Tips and Best Practices to Help Improve Performance

- Utilize the monthly Gaps in Care (GIC) report for a list of MVP members who need preventive care
- Remember that your patient may have had a colorectal cancer screening test prior to their enrollment with MVP
  - Documentation can be submitted to MVP to close the gap in care for this measure—refer to your monthly GIC report for instructions
- Educate Members about all the colorectal cancer screening options available—personalize the advice to the needs and compliance potential of the individual
- A pathology report may be used to confirm colorectal cancer screening if the type of screening and source of specimen is listed
- Consider utilizing alerts or flags within the electronic health record (EHR)
- Discuss the importance of early detection and encourage preventive care
- Document preventive care in the medical record with name of the test, date, and results
- Document medical and surgical history in the medical record and include dates
- Submit all results to your local Regional Health Information Organization (RHIO)
- Use correct diagnosis and procedure codes and submit claims and encounter data in a timely manner
- Don't use "rule out" diagnosis code of active cancer since colorectal cancer screening is a preventive test
