## **Colorectal Screening for MVP Vermont Commercial Members**

As of January 8, 2020, MVP Health Care<sup>®</sup> (MVP) updated colorectal screening requirements for Vermont Commercial Members. The services are no cost-share to the member; however, the diagnosis codes have been expanded.

## MVP covers colorectal cancer screening for Vermont Members as follows:

- Member is 50 years of age or older and can select from the following treatment options:
  - o Annual fecal occult blood testing plus one flexible sigmoidoscopy every five years; or
  - One colonoscopy every 10 years
- Member is at high risk for colorectal cancer\*, or colorectal cancer screening examinations and laboratory tests are recommended by the treating physician.
  - \* Member is at high risk for colorectal cancer if:
    - A family medical history of colorectal cancer or a genetic syndrome predisposing the individual to colorectal cancer.
    - There is a prior occurrence of colorectal cancer or precursor polyps.
    - There is a prior occurrence of a chronic digestive disease condition such as inflammatory bowel disease, Crohn's disease, or ulcerative colitis.
    - Other predisposing factors as determined by the individual's treating physician.

To ensure Member cost-share is waived, the claim should be billed with a modifier PT or 33 and must include one of the following ICD-10 codes:
