Osteoporosis Management in Women who had a Fracture (OMW)



Measure Description

The percentage of women 67-85 years of age who suffered a fracture beginning July 1, 2023, through June 30, 2024, and who had either a Bone Mineral Density (BMD) test or prescription for a drug to treat osteoporosis in the six months after the fracture.

Notes:

Fractures of finger, toe, face, and skull are not included in this measure.

Definitions

Intake Period: A 12-month (one year) window that begins on July 1, 2023 and ends on June 30, 2024. The intake period is used to capture the first fracture.

Episode Date: The date of service for an eligible encounter during the intake period with a diagnosis of fracture

- For an outpatient, observation, or Emergency Department (ED) visit, the episode date is the date of service
- For an inpatient stay, the episode date is the date of discharge
- For direct transfers, the episode date is the discharge date from the last admission

Index Episode Start Date (IESD): The earliest episode date during the intake period that meets all eligible population criteria.

- Members who had a BMD test during the 730 days (24 months) prior to the episode date.**

- Members who had a claim/encounter for osteoporosis medication therapy during the 365 days (12 months) prior to the episode date.**

- Members who received a dispensed prescription or had an active prescription to treat osteoporosis during the 365 days (12 months) prior to the episode date.**

- Members who died any time during 2024.**

- Utilize the monthly Gaps in Care Report (GIC) for a list of MVP Members and the services they still need
- Obtain an annual health history and include review of prescription and OTC medications, nutrition, lifestyle, exercise, fall prevention, preventive care, and medical/surgical history
- Discuss the importance of early detection and encourage preventive care
- Educate patients on primary prevention of osteoporosis
- Follow osteoporosis screening recommendations
- Submit results to your local Regional Health Information Organization (RHIO)
- Use correct diagnosis and procedure codes and submit claims and encounter data in a timely manner
