**Measure Description**

The percentage of Members who are ages three–17 years old and had an outpatient visit with a PCP or OB/GYN and had evidence of the following during 2023:

1. BMI percentile documentation
2. Counseling for nutrition
3. Counseling for physical activity

## **Tips and Best Practices to Help Improve Performance**

- Each encounter is an opportunity to discuss wellness and provide preventive care services; this is important for parents whose compliance with medical care cannot be ensured—for these patients, consider incorporating well components with sick visits
- Services may occur over multiple visits if all components are addressed within the specified timeframe
- Yearly physical examinations should include most if not all the major body systems
- Health Education/Anticipatory Guidance should be discussed and documented at least once per calendar year
- Submit all results to your local Regional Health Information Organization (RHIO)
- Utilize the monthly Gaps in Care (GIC) report for a list of MVP Members who need preventive care services
