Are there services covered before you meet your deductible ?	Yes, Preventive Care, Office Visits, Urgent Care, Emergency Medical Transportation, Emergency Room Care, Prescription Drugs, Pediatric Vision, Dental Class 1	This plan covers some items and services even if you haven't yet met the deductible amount. But a copayment or coinsurance may apply. For example, this plan covers certain preventive services without cost sharing and before you meet your deductible. What is the out-of-pocket limit for this plan ?	In-Network -\$1,800 individual /\$3,600 family. Includes Diabetic Supplies and Equipment.
