The **MVP Dental PPO Plan for Families** covers adults and their dependent children age 26 and under.

As required by the Affordable Care Act (ACA), children up to age 19 enrolled in a health plan must have pediatric dental coverage. The MVP Dental PPO Plan for Families meets the ACA pediatric dental coverage requirement for dependent children up to age 19.
