Annual deductible	\$100
Annual maximum benefit	\$1,000
Additional routine dental visits (exams, x-rays, simple extractions, fillings)	20% of benefit allowed amount, after deductible
Oral surgery	20% of benefit allowed amount, after deductible
Endodontics (root canals)	50% of benefit allowed amount, after deductible
Periodontics	50% of benefit allowed amount, after deductible
Prosthodontics (partial dentures, crowns)	50% of benefit allowed amount, after deductible
Orthodontics	Not covered

You must enroll in an MVP Medicare Advantage plan to enroll in the Optional Supplemental Dental Rider coverage.

## **MVP Medicare Advantage Supplemental Dental Rider FAQs**

No matter which MVP Medicare dental coverage you have in 2021, your plan works the same.

- You can go to any dentist. As part of the MVP Medicare plan dental benefits, members also have access to the DenteMax Medicare network. To confirm if your dentist is part of the DenteMax Medicare network, go to mvphealthcare.com and select Members, then Medicare, then Find a Doctor.
- DenteMax dentists accept a fixed amount for each covered service as payment in full minus any applicable co-insurance responsibility.
   If you see a non-DenteMax dentist, you may be billed for additional costs.

- You will receive an MVP Dental ID card—
   show this card anytime you visit the dentist.
   Your plan benefits will be applied to your
   visit and the services you receive according
   to the dental plan coverage you have.
- If you enroll in the Optional Supplemental Dental Rider, you will receive one monthly premium bill for both your dental rider and Medicare Advantage plan premiums.
- If you enroll in the Optional Supplemental Dental Rider, your dental claims will be listed on the same Explanation of Benefits (EOB) statements as your medical claims.

You can either keep your current MVP Medicare Advantage plan and add the Optional Supplemental Dental Rider or choose a new MVP Medicare Advantage plan to be effective 1/1/2021 and add the Optional Supplemental Dental Rider to your new coverage. Or go to **mvphealthcare.com** and select *Members*, then *Medicare*.
